B. Taxes collected pursuant to this district shall be segregated so as to enable the same to be expended only in the above-described service district that raised the funds. The Wythe County Treasurer shall provide to the County Administrator a report on December 31st and June 30th of each year showing the amounts collected. The County Administrator shall prepare a report detailing the annual expenditures and revenue received.

Section 3 - Purpose of Tax

B. Taxes collected pursuant to this district shall be segregated so as to enable the same to be expended only in the above-described service district that raised the funds. The Wythe County Treasurer shall provide to the County Administrator a report on June 30th of each year showing the amounts collected. The County Administrator shall prepare a report detailing the annual expenditures and revenue received.

Section 4 – Additional Tax Imposed

To provide for additional governmental services not being offered uniformly throughout the county, there is hereby levied an initial tax of \$1.48 per \$100 of assessed value per landowner in this service district. This tax is applicable to each landowner only in the service district irrespective of the number of parcels owned. This tax will exist for a period of seven (7) years or until the actual cost as allowed in Section 3A and the total project construction cost (including relocation of utility lines) is repaid. The estimated project cost attributable to this district is \$97,921.

Add:

Section 4 – Additional Tax Imposed

To provide for additional governmental services not being offered uniformly throughout the county, there is hereby levied an initial tax as shown in chart below. This tax is applicable to each landowner only in the service district irrespective of the number of parcels owned. This tax will exist for a period of seven (7) years or until the actual cost as allowed in Section 3A and the total project construction cost (including relocation of utility lines) is repaid. The project cost attributable to this district is \$91,098.19.
