- ~Site must be cleaned, vacated and ALL refuse REMOVED FROM PARK by the end of the rental period.
- ~Rental fees, less a \$5.00 processing fee, will be refunded for all cancelations made eight (8) or more days in advance of the scheduled rental period.
- ~Rental fees will be refunded if the Wythe County Parks & Recreation Department closes the park.
- ~Permit will be issued to an adult, who will be responsible for the supervision of the entire event and who will be responsible for damage to park property or injury to any party which results from inadequate supervision or carelessness.
- ~This agreement is required of any individual or organization seeking to reserve facilities or property maintained and/or owned by the Wythe County Parks & Recreation Department.

The user hereby agrees to indemnify and hold harmless Wythe County Board of Supervisors, Wythe County Parks & Recreation Commission, Wythe County Parks & Recreation Department, its officers, agents, all employees and volunteers, from any and all claims for bodily injury and/or property damage, including cost of investigation, all expenses of litigation, including reasonable attorney fees, and the cost of appeals arising out of any claims or suits which result from errors, omissions, or negligent acts of the user, his/her agents or employees.
